Please don't feel like I'm complaining - I find great joy in the variety and the opportunity to use my Godgiven skills to serve our Baptist family, but it can be exhausting at times like this! I'm also grateful for the work of the team here at Baptist House and many others who also use their own skills and expertise to support Baptists Together.

However, rest is also important, so I'm certainly looking forward to some time away from the office over Christmas. And in the last month I have found time to book our family summer holiday for 2020, so that is definitely something to look forward to!


INTERIM TEAM LEADER VACANCY

Churches' Ministerial Counselling Service (CMCS)

Ministry can bring its own stresses and ministers are not exempt from the other problems of everyday life arising from family and personal circumstances. CMCS was established to provide confidential, independent help by way of short-term professional counselling. Baptists Together normally subsidise up to 12 sessions. Click here to see who is eligible to benefit from this service.

If as part of a church leadership team, you are unsure how best to support your minister through tough times, it may be helpful to gently remind your minister about this additional source of help. More details can be found on the dedicated website. For those who are eligible via Baptists Together, a contribution of £15 per session is normally expected from the client being counselled, payable direct to the counsellor, with the balance of the counsellor's fees being met by Baptists Together. Click here for details on how to arrange counselling. Please note that a client's name remains confidential at all times and is only known to their counsellor and their Area Co-ordinator.
